

Terms and Conditions of the "WOMEN'S DAY" promotion

§1 GENERAL PROVISIONS

- The organiser of the promotion in the form of discounted ticket sale to the Energylandia Amusement Park, hereinafter referred to as the "Promotion" is ENERGY 2000 SP. Z O.O. ENERGYLANDIA SP.K. with registered offices in Przytkowice (34-141 Przytkowice) at ul. Przytkowice 532 A, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
- 2. Participant an individual who has met the conditions specified in §2 of these Terms and Conditions.
- 3. Terms and Conditions these Terms and Conditions of the Promotion.
- 4. Promotion this promotion, organised under the name of "WOMEN'S DAY".
- **5.** The aim of the Promotion is promoting an active way of spending leisure time.
- 6. Time of duration of the Promotion for the purchase of tickets at a discount is from 28.02.2022 to 06.03.2022.
- 7. Discounted tickets may be purchased: from 28.02.2022 to 06.03.2022, via the Energylandia Amusement Park's website exclusively in the GIFT tab https://ticket.energylandia.pl/en/prezentowe.
- 8. The promotional discounts apply to gift tickets (standard tickets 140 cm and up, standard 2-day Passes 140 cm and up, discounted tickets up to 140 cm, discounted 2-day Passes up to 140 cm) purchased only via our website in the GIFT tab https://ticket.energylandia.pl/en/prezentowe
- **9.** Promotional gift tickets may be used form 02.04.2022 to 30.10.2022 on days and at times in accordance with the Park's Calendar available at: https://energylandia.pl/en/plan-your-stay/calendar/ Amusement Park reserves the right to amend the Park's Calendar.
- **10.** This Promotion does not apply to any of the above-mentioned tickets purchased at the ticket offices of the Energylandia Amusement Park, or from any of the Partners of the Energylandia Amusement Park.

11.	Promotional tickets in a gift and an electronic form are available for purchase at the following prices:
	standard tickets 140 cm and up - 139 PLN /pc.
	standard 2-day passes 140 cm and up – 249 PLN /pc.
	discounted tickets up to 140 cm – 99 PLN /pc.
	discounted 2-day passes up to 140 cm – 179 PLN /pc.

- 12. A promotional gift ticket purchased via the website will be sent to the postal address provided in the order. Sending gift tickets to the indicated address is payable, and is valid in accordance with the price list of the delivery method.
- **13.** Promotional gift tickets shall be presented in the paper form. Promotional electronic tickets shall be presented in the paper form, or on a smartphone.
- **14.** One person/company may purchase up to 10 tickets in all orders.
- 15. Promotional tickets are not subject to further resale, and may not be exchanged for another type of ticket.
- 16. In accordance with the Bylaws of the online ticket sales to the Energylandia Amusement Park, the Seller hereby informs that in the event of ordering an electronic ticket, entitling the holder to enter the Amusement Park, at the specified time listed on the ticket, the Customer's right to withdraw from the contract concluded in this manner, in compliance with Article 38 pt 12 of the Act of 30 May 2014 on Consumer Rights, has been voided.



- 17. Discounted tickets (one-day at 99 PLN, or 2-day at 179 PLN) apply only to children up to 140 cm in height and seniors over 65 years of age.
- **18.** Purchase of the following tickets: Birthday/Expectant Mother/Disabled/KDR (Large Family Card) only at the ticket offices of the Park, upon the presentation of verifying documents.
- **19.** The promotional tickets entitle the holders to use all attractions, as well as the Big Milk Water Park Zone, with no limitations and in compliance with the policies.
- **20.** This Promotion has been organised on the territory of the Republic of Poland, and the participation in it is voluntary.
- 21. Promotions cannot be combined.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

- 1. This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the. Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.

By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.

- 2. The Organisers reserve the right to amend these Terms and Conditions at any time, with no reason given. Such amendments, however, shall not infringe on the rights acquired by the Participants.
